At the end of October, the savings account had \$1,034.03. In November the account gained .04 in interest for a total of \$1,034.07. When we add the savings account and the checkbook the club has a total of

\$6,219.42

The end-of-year report is very difficult to give as I did not have access to the checkbook or bank account until the club changed to Savings Bank of Walpole in June. I did spend a significant amount of time trying to itemize the expenses and deposits for the first 6 months of 2023. I could not make all numbers balance due to insufficient documentation.

There were expenses for insurance, field day, the \$4,000 storage container, and many others, finding all deposits and all expenses and getting it all to balance was daunting. I have all the information that was given to me and you are welcome to try and figure it out, I could not.

For the numbers from June 2023 in the savings account the club started with \$813.85. Since

June there have been \$220.00 in donation and .22 in interest for a total of \$220.22

Starting in June the checkbook had \$5064.85. Since June 1 the club brought in \$300.00 in donations and \$160.00 in dues for a total of \$460.00.

Starting in June the expenses were, P.O Box \$166.00, Pizza Night \$113.49, and Micky workshop \$60.00. Total expenses \$339.49.

As you all know I will be stepping down as treasurer. I will be more than happy to assist with the transfer of duty.

I would like to thank the club for their trust and support in the past year / 6 months.
